

EVUSA Region I Website & Social Media ideas/Outline

My thoughts/plan are to make all of this <u>super user friendly & easy to manage</u>, so no one person has to be constantly updating or uploading. In order to accomplish that, here is a rough draft/outline on my ideas...

- 1. Create a new, paid website to engender professionalism plus ensure longevity and continuity of our digital online presence.
- a. A couple of proposed website suggestions are: "EVUSAregion1" or "regiononevaulting" (.org = \$3/1st yr, \$20/year thereafter AND .com=\$1/1st yr, then \$17/yr thereafter. That Price is using the host "lonos" (whom we have personally used for many years).
- b. create/use dedicated email addresses (instead of multiple "private" emails) "attached" to the website. This will also ensure email communication in one place, and accessible to "admins"/board..
- c. Propose we hire Jim Leung, (or any other website creator), to create a basic Wordpress website that is VERY user friendly, so that we can maintain ourselves, moving forward. (OCV has also used Jim for many years). Jim will do this for \$350.
- d. Create/setup Google Calendar((which would also include Google Drive/Email) that "subscribes" to each club's Calendar, so that events can be added by each club, and auto-populate to "main" calendar. (If AVA/EVUSA ever returns to Google Calendar we can also subscribe to that and have competition info auto-populate as well)
- e. Put the following items into Google drive documents, with a link to the website. This way documents do not need to be "uploaded" when revised or changed (we just upload/create a new version, and it is accessed/viewed via the link.

i.Bylaws

ii.Rules

iii.Meeting Agendas & Minutes

iv.Current board member names & contact info

- f. Use Google Maps, for Club info & data (also automatically updated/revised as source document is updated).
- 2. A "redirect" from old URL, to new, should happen (if possible. However, as the prior URL was free, this may not be an option).
- 3. Create & manage the following Social Media outlets:
- a. Instagram, connected to Region 1 page
- b. YouTube channel, with playlists populated with educational materials and available to (? members only or everyone).
- c. TikTok

- d. Create Social Media & Photo content posting guidelines to help guide those working on, and keep posts consistent with Region goals, (OCV Photo content guidelines here & DRAFT version of AVA Social Media Posting Guidelines, here. (Our Region guidelines should be reviewed by board, and amended as desired).
 - 1. Would love to have one, or more youth council people helping with original creative content & design, as well as maintaining & continually updating Social Media aspects. It is my hope & dream to have several people who can help with website, continually while having a set set of guidelines to ensure consistency.


